Terms & Conditions Instrument Rental Agreement

The undersigned agrees to the following conditions for the duration of the agreement regarding the instrument rental:

- Full responsibility for the timely payment of all instrument rental fees belongs to the user of the instrument. User will receive a fees payment schedule at the inception of the rental agreement, in accordance with the agreed upon terms of rental. Full Year and Fall Semester Fees MUST be paid by the September 20th and Spring Semester fees must be paid by February 20th. Delinquent accounts will be turned over to the Cario Middle School bookkeeper for collection. Fees assessed and payments applied will be noted in the band student's account. Information regarding the band student's account is sent out periodically during the school year and may also be obtained at any time by contacting the Band Booster treasurer.
- Full responsibility for the proper handling and care of the instrument belongs to the user of the instrument.
- Full responsibility for any necessary repairs to the instrument, (e.g. lost pad, bent rod, dented valve casing, etc.), belongs to the user of the instrument and said repairs MUST be attended to in a timely manner.
- Full responsibility for a lost, stolen, or destroyed instrument belongs to the user of the instrument and said instrument MUST be replaced in kind in a timely manner.
- Full responsibility for forfeiture of the instrument belongs to the user of the instrument for the following reasons:
 - Negligent treatment of the instrument
 - A failing band grade in any 9-week period
 - Failure to comply with fees payment schedule
- Full responsibility for the procurement of a replacement instrument belongs to the user of the instrument in the case of forfeiture and MUST be attended to in a timely manner.
- Full responsibility for returning the instrument to the Cario band room at the expiration of the rental term belongs to the user of the instrument. Instrument and all accessories MUST be returned in the same condition as received, accepting reasonable wear and tear.
